# Territory Artists Competition

#### COMPETITION

- 1. Information on how to enter and prize details form part of these conditions. Entry into this Competition is deemed acceptance of these terms and conditions.
- 2. The "Promoter" is Northern Territory Major Events Company (ABN: 22 085 961 520) of 16 Bennett Street, Darwin, Northern Territory 0800 ("NTMEC").

#### PROMOTION PERIOD

- 3. The Competition commences at 9.00am Australian Central Standard Time ("ACST") on Friday 19 April 2024, and will continue until 5.00pm ACST on Friday 3 May 2024 ("Promotion Period").
- 4. Winners will be announced on the BASSINTHEGRASS Facebook and Instagram page on Wednesday 08 May 2024.

#### **ELIGIBILITY**

- 5. Entry is open to Northern Territory residents only, proof of residency will be required.
- 6. Eligible Entrants must have a minimum of four original tracks in their repertoire.
- 7. Eligible Entrants expressly exclude management and other employees of the Promoter, event partners and any agencies, firms and/or companies (and their immediate families), who are directly associated with the Promotion.
- 8. Eligible Entrants must have an ABN for receipt of payments.

# HOW TO PARTICIPATE

- 9. To enter the competition, an Eligible Entrant must submit a complete application form at www.bassinthegrass.com.au.
- 10. After the closing date, applications will be presented to a panel of four judges and the successful artists will be chosen at their discretion; the judges' decision is final.
- 11. Winners will be announced on the BASSINTHEGRASS Facebook and Instagram page on Wednesday 08 May 2024.
- 12. This competition is based on skill and chance plays no part in determining the winner.
- 13. Winners give NTMEC permission to publish their images on social media.

#### **PRIZES**

- 14. The following prize (Prize) will be provided by the Promoter to two (2) Winners:
  - a. The opportunity to play a 20 minute live set at BASSINTHEGRASS 2024 on Saturday 18 May 2024.
  - b. Entry accreditation to BASSINTHEGRASS 2024.
  - c. 2 x General Admission tickets per artist
- 15. The Prize must be used by the Winners on 18 May 2024 only.
- 16. Winners may be required to participate in media calls as part of the Promotion.
- 17. Winners selected will be supported by way of:
  - a. Artist fee of \$750
  - b. Contribution to travel, accommodation and logistic costs of up:



- \$350 if the 50% of the artists/bands is located within 250km of Darwin
- ii. \$500 if 50% of the artists/bands are located within 250km 500km of
- iii. \$750 if 50% of the artists/bands are located within 500kn 750km of Darwin
- iv. \$1250 if 50% of the artists/bands are located within 750km 1000km of Darwin
- v. \$1500 if 50% of the artists/bands are located over 1000km of Darwin
- c. Standard backline and production
- 18. The Prize is not transferable, exchangeable or redeemable for cash.
- 19. If the winners are unable to play at the event on the dates specified, they forfeit the opportunity and the opportunity will not be carried forward to future events.
- 20. The Winner's performance time and location will be at the discretion of the Promoter and non-negotiable.
- 21. The Promoter reserves the right to change the Prize for any reason whatsoever.

# NOTIFICATION

- 22. If the Winners, after accepting the Prize, are physically unable to claim their Prize, a replacement Winner will be selected at the discretion of the Promoter
- 23. The Winners consent to their name being published on the Promotor's website and social media channels.
- 24. The Winners agree to participate and cooperate as required in all editorial activities relating to the competition, including but not limited to being interviewed, photographed and broadcast. The Winners agree to grant the Promoter a perpetual and non-exclusive licence to use such footage and photographs in all media and the Winners will not be entitled to any fee for such use.
- 25. The Promoter will hold the copyright to any photographs, video footage or written comment taken for publicity purposes and can use these items in any promotional material unconditionally.

#### **GENERAL**

- 26. To the extent permitted by law, the Promoter shall not be liable for any loss or damage whatsoever (including but not limited to direct or indirect loss) or personal injury suffered or sustained in connection with this Promotion.
