

BASSINTHECITY: WIN AN UPGRADE TO THE REFRESH ZONE AT BASSINTEGRASS 2024

CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry. This is a game of chance.
2. **Promoter:** Northern Territory Major Events Company Pty Ltd (ABN 22 085 961 520 7)

ELIGIBILITY

3. Entry is only open to residents of Australia and New Zealand ("**Entrants**"). The directors and management of the Promoter, its related suppliers, contractors and agencies whom are directly associated with the conduct of this promotion are ineligible to enter the promotion.
4. Entries are only open to those aged 18 years or above. The Refresh Zone at BASSINTEGRASS 2024 is a strict 18+ zone.
5. These Conditions of Entry will bind the Entrants. If any prize winner is aged under 18 years, the competition will be redrawn and the next randomly drawn winner will be awarded the Major Prize.

PROMOTIONAL DATES

6. The Promotion commences at 6:00pm Australian Central Standard Time on 15 May 2024 and closes at 9:00pm pm Australian Central Standard Time on 15 May 2024 ("**Promotion Period**").

HOW TO ENTER

7. To enter the promotion, Entrants must, during the Promotional Period:
 - (a) Show receipt of BASSINTEGRASS 2024 General Admission yicket purchase to promotional staff at the 2024 BASSINTEHCITY event stall and;
 - (b) Submit the Competition Entry Form via QR code at the 2024 BASSINTEHCITY event stall. The form **MUST** include a valid Moshtix Order no. and be submitted between the hours of 6pm to 9pm Australian Central Standard Time on Wednesday, 15 May 2024.

(together an "**Entry**").
8. Only one Entry is permitted per Entrant, per email address. Multiple Entries will be considered void.
9. Entrants acknowledge that their Entry may be featured on the Promoter's website and/or social

media channels for public viewing during the Promotional Period and in perpetuity. Once an Entry is submitted, Entrants acknowledge that the Entry may not be withdrawn, altered or deleted (except as and where required by the Promoter).

10. Costs associated with accessing the Internet remain the Entrant's responsibility and may vary depending on the Internet service provider used.

WINNERS AND PRIZE

11. Three (3) Entrants with a valid Entry who are randomly chosen (in accordance with the rules of the competition) will win a ticket upgrade of their existing 2024 General Admission Ticket to a Refresh (18+) at BASSINTEGRASS 2024 (the "**Major Prize**"). The winner will also win a secondary upgrade to 'bring a friend' which they can gift to any patron that has purchased a 2024 BASSINTEGRASS event ticket that is over the age of 18 years. Both the randomly drawn name winner and the 'bring a friend' winner will be considered 'entrants' and therefore bound to these Terms and Conditions.
12. The total indicative value of the Major Prize is between A\$100.00 and A\$165.00 inc. GST, dependant on the price category of General Admission BASSINTEGRASS Ticket that was originally purchased by the competition winner.
13. The Promoter reserves the right to offer other secondary prizes on an ad hoc basis (whether week-to-week or otherwise) and in its sole discretion.
14. Winner will be notified in writing via email and will be invited to contact the Promoter directly to provide their details so the Promoter can deliver the prize. Judges' decision is final and no correspondence will be entered into. If for any reason the winner does not take the prize at the time specified by the Promoter, the prize will be forfeited and cash will not be awarded in lieu.
15. Prize Conditions for event tickets: **Any ticket prizes may not, without the written consent of the Promoter or its agents, be resold or offered for resale (including via online auction sites) or used in any advertising, promotion or other commercial purposes. If a ticket is sold or used in breach of this condition they will be cancelled. Any tickets that are lost, stolen or damaged will not be replaced.**

GENERAL

16. Prizes are not transferable or exchangeable and cannot be taken as cash (unless otherwise indicated).
17. Prizes must be taken as offered by the Promoter and cannot be varied. The Promoter accepts no responsibility for any tax implications that may arise from any prize. Independent financial advice should be sought. The Promoter accepts no responsibility for any variation in prize value.
18. The Promoter reserves the right to request the Entrant produce (within the requested time) appropriate photo identification or other documentation (to the Promoter's satisfaction, at its sole discretion) in order to confirm the Entrant's identity, age, residential address, eligibility to enter and claim a prize, and any information submitted by the Entrant in entering the promotion, before issuing a prize. If the documentation required by the Promoter is not received by the Promoter (or its nominated agent) or an Entrant or entry has not been verified or validated to the Promoter's satisfaction then all the entries of that Entrant will be ineligible and deemed invalid.

The Promoter's legal rights to recover damages or other compensation from such an offender are reserved. A prize will only be awarded following any Entrant validation and verification that the Promoter requires in its sole discretion.

Nothing in these Conditions of Entry limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia (Non-Excludable Guarantees). The Promoter, its associated agencies and companies excludes all liability (including negligence) except for any liability that cannot be excluded by law (including the Non-Excludable Guarantees), for any direct or indirect injury, loss and/or damage arising in any way out of the promotion. This includes, but is not limited to: (i) technical malfunctions, delays or failures, including those resulting from accessing any materials related to the promotion and any incorrect, inaccurate or incomplete information communicated in the course of, or in connection with, the promotion as a result of any technical malfunctions, delays or failures; (ii) theft, unauthorised access or third party interference; (iii) lost or damaged entries, prize claims or prizes; and/or (iv) acceptance and/or use of any prize.

As a condition of entering this promotion, an Entrant consents to, in the event they are a winner, the Promoter using the Entrant's Entry, name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period of time without further notification, remuneration or compensation for the purpose of promoting, publicising or marketing the promotion (including any outcome), and/or promoting any products or services manufactured, distributed and/or supplied by the Promoter. The Entrant agrees that, in the event they are a winner, the Entrant will participate in all reasonable promoted activities in relation to the promotion as requested by the Promoter and its agents.

Promoter reserves the right to change, add or alter any of the terms and conditions (including adding more prizes but not reducing the number of existing prizes) if in the absolute discretion of Promoter it is in the interest of the Competition or is otherwise desirable, and such change will be notified to the Entrant by being placed on the Website and each Entrant will be bound by such change, addition or alteration to the Terms and Conditions.
